- Provide direct care to residents demonstrating expertise in contemporary clinical practice and acting as a role model for staff.
- Ensure accurate completion of all documentation required for ACFI submission is completed in a timely manner in consultation with the ACFI Coordinator.
- Ensure that administration of medications is in accordance with legislative and regulatory requirements.
